The persons/ bodies who are willing to purchase the above vehicle may apply by submitting their offer letter in sealed envelope super scribed “ Offer for Cash Van” stating therein the price at which they are willing to purchase the vehicles on or before 05/10/2021 up to 1400 hrs. Offer letter may be send by post of by hand.
2. The application for purchase of the vehicles should be submitted in the prescribed format available at our office during office hours at a price value of Rs.100/- (Rs. one hundred only) or may be downloaded from bank website www.centralbankofindia.co.in and may send with fee. Application fee will be non-refundable.
3. Application will be free of cost for bank staff/ex-staff members.
4. The Duly filled up form in the prescribed format in sealed envelope be addressed to the Regional Manager as above said address and be accompanied by DD by any national bank in favour of Central Bank of India, Regional Office, payable at Nasik as EMD.
