6. **A SEPARATE BID MUST BE SUBMITTED FOR EACH VEHICLE IN WHICH THE BIDDER IS INTERESTED AND AN ENVELOPE THAT MUST BE SUPER SCRIBED AS “FOR PURCHASE OF CASH VAN REGISTRATION NO. e.g OR-02-AZ-6544”**
7. **Earnest Money Deposit of Rupees 10000/- (Rupees Ten Thousand Only) per vehicle for General Public and Rupees 5000/- (Rupees Five Thousand Only) for Staff and Ex-staff shall be paid along with the offer for each vehicle separately. The DDs / Pay Orders for application (as mentioned in para I above) and EMDs must be enclosed with the Bid.**
8. The successful bidder has to pay the full amount for each vehicle less amount of EMD for each vehicle within **seven days** from the date of receipt of intimation (Excluding) by means of **DD / Pay Order favoring Central Bank of India and payable at Bhubaneswar**. Failure to make payment of the full amount in time may result in forfeiture of the offer to purchase the vehicle as well as the EMD submitted. Application forms without application fee or EMD will be summarily rejected. Presence of respondents during the opening of the tender on the appointed date and time will be allowed and they will be informed about the same through Letter / email.

In case of no response from H1 bidder or if the H1 bidder refuses to accept the vehicle bid for due to any reason, the EMD shall be forfeited and offer will be extended to H2 bidder (H2 to match the rate of H1). Similar procedure shall be followed in respect of H2 / Hg etc. as long as the Bank is able to get a price above the Reserve Price. Vehicle shall not be disposed off below the Reserve Price.

 - a) The tender bid without Tender Fee and Tender Deposit will not be entertained.
 - b) The successful bidder will be required to deposit the balance bid amount after deducting Earnest Money Deposit as mentioned above

The Bidder must submit the documents required to be submitted along with the bid to avoid rejection of the application.

- e) The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously.
- f) If vehicle is taken with RC, the vehicle shall be handed over to the buyer only after it is registered in the name of the buyer by RTO and documents to this effect are obtained.
- g) Approval of sale offer is subject to Bank's internal procedure and as such participating bidders have no right to claim interest on the Earnest Money deposited by them with the Bid/ Quotation/ sale offers.
