- Interested individuals (including legal person), including staff & ex staff are required to submit Bid as per format provided in a sealed cover with non-refundable application fee of Rs.500/- (waived for staff & ex staff) and **Earnest Money Deposit -EMD (refundable) of Rs.10000/- for general public and Rs.5000/- for staff & ex staff by way of Demand Draft favoring “Central Bank of India”.**
- The tender bid without Application Fee and Earnest Money Deposit will not be entertained.
- The vehicle will be available for inspection between 10 am to 5 pm on all working days w.e.f 06.06.2022 to 20.06.2022, parked at Central Bank of India, Regional Office, Astley Hall, Rajpur Road, Dehradun, 248001. (Near Mc Donalds).
- The sealed cover should boldly super scribe “**TENDER BID FOR PURCHASE OF BANK'S VEHICLE**”, and should reach to our office at Central Bank of India, Regional Office, Astley Hall, Rajpur Road, Dehradun, 248001. (Near Mc Donalds) on or before 5:00 pm on 20.06.2022. Any Bid received thereafter will not be entertained.
- Tender will be opened on 21.06.2022 or any later date decided by our office.
- Insurance/Road tax will not be transferred in the name of the purchaser by Bank.
- Applicant with highest Bid will be given 7 days' time for making full payment. If no response is received from the highest bidder, the Earnest Money shall be forfeited and offer extended to

second highest bidder (H2 to match the rate of H1). Similar procedure shall be followed in respect of H2/H3/H4 etc. till the Bank is able to get the reserve price.

- GST @18% will also be applicable on the offer price.
- The vehicle will be delivered to the buyer only after all formalities (registration transfer by RTO, Insurance transfer etc) are completed by the buyer on his/her own cost & effort and the documents to this effect are given to the Bank.
- For getting the vehicle registered at the place of choice of the Buyer, the Bank will extend co-operation by way of giving the required letter/certificate for obtaining NOC/transfer. While the responsibility for NOC, transfer/registration will be of buyer only.
- Buyer has to get the vehicle transferred/registered in his/her name within one month from the date of NOC as per Motor Vehicle act.
- Bank will be discharged from its liability from the date of sale of vehicle.
- Buyer should submit self-attested Xerox copies of their PAN, AADHAR & Driving License along with the application form.
- The refundable deposit will be refunded only on production of the proof (copy of RC with due endorsements) of having the vehicle registered in the name of buyer.
- All charges/expenditure occurred in transfer/registration or any nature will be borne by the buyer only and the Bank will not compensate in any manner.
- In case of any dispute, jurisdiction will be restricted to Dehradun only.
- Bank reserves its right to accept/reject any tender/proposal without assigning any reason.
