- a) The refundable deposit will be refund only on production of the proof (Copy of RC with due endorsement) of having the vehicle transferred in the name of purchaser.
- b) **THE DELIVERY OF THE SOLD VEHICLE WILL BE GIVEN ONLY AFTER THE COMPLETION OF RTO FORMALITIES BY THE BUYER. GST would be paid by the successful bidder. In the case of 'Insurance Transfer', proportionate balance premium will be recovered from the successful bidder.** Format for submission of "Personal Particulars" and the "Bid" is attached as **Annexure A & B** respectively with this tender notice. The Bidder must submit the documents required to be submitted along with the bid to avoid rejection of the application.
- c) The sold vehicle shall have to be removed by the successful bidder within 7 days at his own expense.
- d) The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously.
- e) Approval of sale offer is subject to Bank's internal procedure and as such participating bidders have no right to claim interest on the Earnest Money deposited by them with the Bid/ Quotation/ sale offer.
