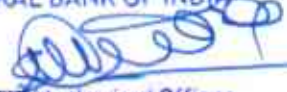

Terms & Conditions for E - Auction

1. The e-Auction is being held on "AS IS WHERE IS", "AS IS WHAT IS", "WHATEVER THERE IS" and "NO COMPLAINT BASIS" subject to the provisions of SARFAESI Act & rules. The E-Auction would be only through "Online" & the process through the website of service provider i.e. <https://www.cbkray.in>. Platform.
2. The intending Bidders/Purchasers are requested to register on portal (<https://uat.cbkray.in/psb-alliance-web/bidder-registration>) using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider, the intending Bidders/Purchasers has to transfer the EMD amount using online mode well in advance before the auction time. In case EMD amount is not available, system will not allow to bid. The registration, verification of KYC documents and transfer of EMD must be completed well in advance, before auction. Bidders may give offers either for one or for all the properties.
3. The Persons holding valid User ID & Password for e-bkay portal and confirmed payment of EMD through NEFT/RTGS shall be eligible for participating in the e-Auction process. Successful bidder would have to produce KYC documents in original to the Bank at the time of making payment of 25% of bid amount(less EMD already paid).
