'Google must give status to contractors'

A GROUP OF Democratic senators has demanded in a letter sent to Google's chief executive, Sundar Pichai, that the internet giant convert its more than 120,000 temporary and contract workers to full-time employees. The letter, written by Senator Sherrod Brown of Ohio, also urged Google to stop its "anti-worker practices" and treat everyone at the firm equally.

"Making these changes to your company's employment practices will ensure equal treatment of all Google workers and put an end to the two-tier employment structure you have perpetuated," Brown wrote. Among the 10 senators who signed were three running for president: Kamala Harris, Bernie Sanders and Elizabeth Warren.

As of March, Google had more temporary workers than

full-time employees. 121,000 temporary workers and 102,000 permanent employees, according to a report viewed by The New York Times. The senators' letter, sent last month, outlined how Google's shadow work for contractors and contract workers through staffing agencies pushed the company to change its treatment of temporary workers.

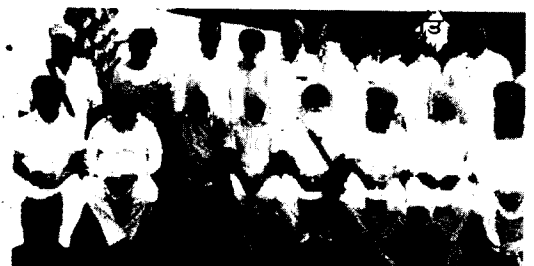
