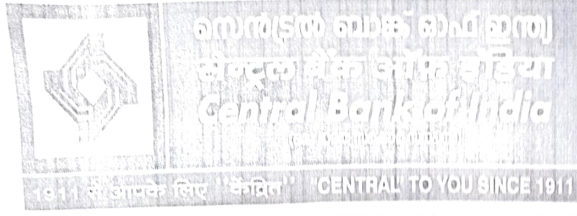

4. The rate/quotation should be mentioned in figures as well as in words. In case of ambiguity in ascertaining the quoted amount, the amount mentioned in words shall be taken as the quoted amount.
 5. Sealed quotation with specific vehicle registration no. superscripted on the envelopes has to be submitted by **Register Post/Speed Post only**. Submission of quotation by Hand delivery, by Courier or by any other means shall not be accepted.
 6. The sealed quotations must reach the Authorized Officer before 5:00 p.m of 19.03.2026.
 7. The Quotations will be taken for consideration/ treated as valid, only if EMD amount is deposited for each of the vehicle.
 8. Payment/ deposit of EMD can be made by way of Demand Draft/NEFT.. If EMD is to be deposited through Demand Draft, the same must be drawn in favour of "Authorised Officer SARFAESI ACTION". IF EMD is to be deposited through NEFT, the payment must be made as per the specification given below.

9. If the EMD is deposited through DD, it should be particular of the vehicle for which the EMD is given should be mentioned in the reverse of the DD.
 10. For every separate quotation, separate payment towards EMD has to be made. If a person wants to participate in sale of more than one vehicle, and submits quotations, for each of such quotation, separate payment of EMD shall be made. Clubbing of EMD together is not permissible.
 11. Received quotations will be opened on 20.03.2026 at 3:00 PM in the office of Authorised Officer at Regional Office, 1st Metro Palace, Opp. Ernakulam Town Railway Station, Cochin – 682018.
 12. The acceptance of quotation shall rest with the discretion of Authorised Officer, who shall have the right to reject any or all of the quotations received without assigning any reason.

13. Any person intending to submit quotation is advised to inspect and examine the vehicle and satisfy himself before submitting his quotation. Any person submitting

quotation shall be deemed to have full knowledge of the physical and mechanical condition of the vehicle, whether he inspected it or not.

14. A purchaser selected will have to pay at least 25% of the quoted amount within the next working day from the date of receipt of information about the selection of his quotation as successful quotation. The rest amount has to be paid within a period of 15 days from the date of declaration. Failure of payment in the stipulated manner shall cause cancellation of the quotation and forfeiture of the entire amount already deposited. The purchaser has also to bear and pay the encumbrances if any known to the secured creditor.
15. The selected purchaser shall be given sale certificate after payment of the entire sale price (plus GST). All documents relating to transfer of vehicle shall also be provided to the purchaser. It will be the sole responsibility of the purchaser to get the Vehicle registered in his name.
16. All the expenses of transfer and removal of the hypothecation and other formalities to complete the transfer of title from the name of the owner of the vehicle in the name of the Purchaser etc., will have to be borne by the purchaser only.
17. Physical possession of the vehicle shall be handed over to the purchaser ONLY when the Purchaser produces sufficient and satisfactory proof of submission of application before RTO for transfer of the vehicle in his name.
18. The purchaser has to bear the parking & security charge (if any) after issuance of the sale certificate upto the date of handing over physical possession.
19. All intimations to quotation maker/purchaser will be primarily through e-mail. If no intimation reaches, the quotation makers may get status of the process from the office of the Authorized Officer. Non receipt of intimation should not be an excuse for default/non-payment of the quoted price amount within the stipulated period.
